What is this product?

Type The product is in the form of a debt instrument.

Objectives To provide you with an exposure to the Underlying(s), whilst providing for a minimal return of 85% of the Nominal Amount at maturity.

• Redemption on the Maturity Date:

○ Redemption Amount:

- If the Final Underlying Performance is lower than or equal to 0%, you will receive the Nominal Amount plus an amount equal to the absolute value of the Final Underlying Performance multiplied by the Nominal Amount and further multiplied by the Upside Participation Rate. The absolute value of the Final Underlying Performance is subject to a maximum equal to 10%.
- If the Final Underlying Performance is greater than 0%, you will receive the Nominal Amount diminished by an amount equal to the Final Underlying Performance multiplied by the Nominal Amount. Early redemption and adjustments

The terms of the product provide that if certain defined events, in addition to those described above, occur (principally but not exclusively in relation to any Underlying, or the Issuer of the product (which may include the discontinuation of the Issuer's ability to carry out the necessary hedging transactions)), adjustments may be made to the terms of the product to account for the relevant event or the product may be early redeemed. The amount paid on any early redemption may be less than the amount originally invested.


Intended retail investor

This product is primarily intended for investors who:

- are looking for capital growth, and are expecting the underlying to perform in a way that generates a favourable return;
- are willing and able to bear a partial loss of their investment, and accept the credit risk of the issuer;
- are willing to accept a level of risk that is compatible with the summary risk indicator shown below;
- have the ability to make an informed investment decision through sufficient knowledge and understanding of the product and its specific risks and rewards, potentially resulting from experience of investing in and/or holding a number of similar products providing a similar market exposure or relevant training activities;
- have a minimum investment horizon consistent with the maturity date of the product.

What are the risks and what could I get in return?

Summary Risk Indicator



The risk indicator assumes you keep the product until 27 September 2021. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because Handelsbanken is not able to pay you. We have classified this product as 3 out of 7, which is a medium-low risk class. This classification takes into consideration two elements: 1) the market risk - that rates the potential losses from future performance at a medium-low level; and 2) the credit risk which estimates that poor market conditions are very unlikely to impact the capacity of Handelsbanken to pay you. You are entitled to receive back at least 80.952% of your capital. Any amount over this, and any additional return, depends on future market performance and is uncertain. However, this protection against future market performance will not apply if you cash-in before 27 September 2021. If Handelsbanken is not able to pay you what is owed, you could lose your entire investment.
